



Which of the following areas best describe your work in audio? Check all that apply.



How optimistic or apprehensive do you feel about the impact of AI on your work? 52 responses




How much creative potential do you see in the AI technologies used in your area of work? 52 responses




How much does AI technology improve efficiency in your work?
